# MET Gifting

- MET offers purchasers three payment options:
  - Lump sum payments, by 15 credit hour semesters, up to 10 semesters.
  - Monthly purchase, by 15 credit hour semesters, structured payments over 4, 7, 10 or 15 years.
  - Pay-As-You-Go, open a contract with the minimum purchase of one credit hour, then make payments "at will" with minimum \$25 contribution.
     Purchasing credits, or fractions of credits at rate at time of contribution.
